### An Example in Seattle

Stocked with Fentanyl test, IM naloxone, nasal naloxone, and safe sex kits

Managed by King Co (Thea Oliphant-Wells) who restocks. They also run the back-end website (via RedCap, an academic research site). Client points phone at QR code and fill out a few questions.

If no phone, then the volunteer staffing the desk gives a code. Can take 2 items every 7 days.

Noted that the police sometimes dash in to get naloxone

Caracole is the local HIV organization that provides housing and case management services. They have a vending machine outside their brick and mortar that's accessible 24/7 and includes many products you would normally get from a syringe service program.

Thea stocks the machines herself

Naloxone and Fentanyl test strips in their machines

They have two machines in 2 different places. Person interacts with another person to access code to use the machine. There is QR access too.

Inside machines are about \$5K

Outside machines are about \$10K

Wenatchee and Omak will soon have machines

Money/funding sources: NACCHO –through the Implementing Overdose Prevention at the Local Level (IOPLL) funding. City funding. 1/10 of 1% funding.

Their machines are in: Kent and Seattle



Another method to provide emergency naloxone access.


